QUALIFYING INFORMATION FOR PLAYERS**

**FORMAT/QUALIFYING PLACES:** 18 Holes of individual stroke play qualifying. Players will be competing for 2 qualifying spots and 2 alternate positions. Successful qualifiers will advance to the 61<sup>th</sup> U.S. SENIORS WOMEN'S AMATEUR CHAMPIONSHIP, Troon Country Club, Scottsdale, Arizona. September 30 - October 5, 2023

**STARTING TIMES:** Starting times and pairings will be released on Friday, August 18<sup>th</sup>. Starting times, pairings and complete results can be found by visiting Mexican Woman's Golf Association website at [www.amfg.org.mx](http://www.amfg.org.mx).

**PRACTICE RANGE:** The practice range will open one hour prior to the first starting time.

**PLAYOFF:** In the event of a tie for the last qualifying places, there will be a hole-by-hole playoff to determine the final qualifiers and the 1<sup>st</sup> and 2<sup>nd</sup> alternate, if necessary.

**FOOTWEAR:** Shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during the stipulated round. Penalty for breach of this condition: DISQUALIFICATION.

**GROOVES:** The players clubs **must conform** to the grooves and punch mark specifications in The Rules of Golf that are effective from January 1, 2010 (see Decision 4-1/1).

**DISTANCE MEASURING DEVICES:** A player may obtain distance information by use of a distance-measuring device. If, during the **round**, a player uses a distance-measuring device to gauge or measure other conditions that might affect his play (e.g., elevation changes, wind speed, etc.) the player is in breach of Rule 14.3, for which the penalty is Two Strokes and for any subsequent offense of Rule 4.3 – Disqualification.

**EVACUATION PLAN:** In the event of a discontinuance of play during the qualifier, players must adhere to the evacuation plan distributed by the Committee at their appropriate starting tee.

**PRACTICE ROUND AVAILABILITY:** Reservation at 55 54872000 (Javier Licea).

**QUALIFYING ROUND FEES:** Fees are included in the USGA Championship entry fee.

**CADDIES:** Are permitted, fee \$ 800.00 plus tip.

**TRANSPORTATION:** Rental cars are available fee, \$ 870.00 **NO MORE THAN ONE PERSON RIDING THE CAR (PLAYER OR CADDIE) CREDIT CARD ONLY.**

Push / Pull Carts are permitted.

**GOLF SHOP/LOCKER ROOM/PRACTICE AREAS:** Players will have limited access to clubhouse and access to locker room, grill and pro shop.

**PERSONAL APPEARANCE:** Contestants and caddies must be neat in appearance.

**FOOD SERVICE:** opens at 7:00 am, food and beverages will be available on site for purchase. Credit cards are accepted at the club.
